

# MHACBO Recertification Guide

## Recertification every two years:

All MHACBO Certifications are valid for a period of two years. Recertification occurs every two years.

## Process:

To recertify you must present Continuing Education Hours that occurred during the two years prior to expiration. For example, if you were certified January 1, 2020 and you expire January 1, 2022, we will accept continuing education hours that occurred during that two year period. To recertify, you will need to access your recertification application posted in your personal Certemy account.

## Extensions:

If you need to file for an extension, go to MHACBO Forms and select either a no-cost 30-day extension or a 120-day extension. Complete the online extension application form.

## Accepted CEUs:

MHACBO accepts continuing education hours that are provided within OHA state approved agencies, MHACBO accredited continuing education hours, any accredited colleges or universities and education accredited by a host of state and national organizations detailed on the next page.
